

### Tustin Economic Development Meeting City of Tustin Project Updates Prepared By: City of Tustin Community Development Department March 14, 2019

#### **Old Town Updates**

• Vintage (420 W. Sixth Street): This new 140-unit residential community will feature amenities such as a pool, clubhouse, and a new mini-park. In addition, a new freeway sound wall has been constructed, which now features a monochrome City of Tustin logo, and a sign featuring Old Town Tustin. Construction continues to progress on these units, and the model homes are now open. Please refer to Attachment A for an exhibit displaying the active and completed permits for this project.



### **Tustin Legacy Updates**

• Levity in Tustin Legacy (Tustin Ranch Road/Victory Road): In January 2018, the City Council approved the development of a new 218-unit residential community by CalAtlantic Homes. This project features three (3) new neighborhoods: Fleet at Levity – townhomes; Velocity at Levity – flats; and, Icon at Levity – single family homes. Framing is well underway for the model homes. Please refer to Attachment B for an exhibit displaying the active and completed permits for this project.

- The Village at Tustin Legacy (Kensington Park Dr. / Edinger Avenue): Construction continues to progress on the medical office portion of this new center which includes 248,292 square feet of retail and medical uses. The Health South (acute care) facility is anticipated to commence with grading of their site in the near future.
- Flight at Tustin Legacy (Barranca Parkway/Red Hill Avenue): This development proposal includes a variety of uses such as: creative office uses; a food hall; and, conference center including a connection into Tustin Legacy Park. Construction is currently in progress at the site. The core office buildings are anticipated to be complete in the first quarter of 2019. The food hall is anticipated to open in March 2019.



• Veterans Sports Park (Valencia Avenue): This approximately 30-acre park is designed as a community/sports park and will accommodate large group activities and offer a wide variety of facilities including: Four (4) lighted soccer fields; three (3) lighted ball fields; four (4) lighted tennis courts; two (2) lighted basketball courts; two (2) lighted sand volleyball courts; eight (8) lighted pickleball courts; a skate park; and, a veteran's memorial. The veteran's plaza and memorial area, designed as a place of honor, will be located at the west side of the park. Grading work is complete at the site, and bids have been collected for Phase II of the project (which includes construction of the ball fields and equipment). Construction of the park is in progress, and the park is anticipated to be complete in

early 2020.

- The Yellow Chilli (2463 Park Avenue): On July 23, 2018, the Zoning Administrator approved a request to establish a Type 47 ABC License in conjunction with outdoor seating at an existing tenant space within The District (former Sharky's location). The new Indian restaurant is anticipated to open soon.
- Utopia Café (2489 Park Avenue): This European café serving lunch and dinner is now open in the former Peets Coffee location.

#### Other Updates


• **Property Commendation (195 El Camino Real):** On March 12, 2019, the Planning Commission recommended that the City Council commend the property located at 195 El Camino Real as an outstanding property in Old Town Tustin. The property has been nominated as a wonderful example of a modern building which seamlessly blends in and enhances the Old Town built

environment, and aligns with the visions as identified in the Downtown Commercial Core Plan. The City Council will consider the commendation on <u>April 2, 2019 at 7:00 p.m.</u> in the Council Chamber.

 Schools First Credit Union (15332 Newport Avenue): Schools First has submitted plans for a new three-story 180,000 square foot facility, including a 5,000 square foot branch building. The plans are currently under review by City Staff. Please refer to Attachment D for a map of

 Costco Gas Station (2655 El Camino Real): Plans have been submitted, and are currently under review by City staff, to construct a new gas station adjacent to the existing warehouse site. TED Meeting March 14, 2019 Page | 4


- Family Promise Transitional Housing (1914 El Camino Real): On November 6, 2018, the City Council adopted an Exclusive Negotiating Agreement with Family Promise of Orange County, who is proposing to construct a project consisting of seven (7) units, including a family resource center, for the purpose of providing short-term transitional housing for homeless families.
- Rock & Brews (1222 Irvine Boulevard): On August 14, 2018, the Planning Commission approved a request to expand the former Lone Star Steakhouse converting it into a Rock & Brews Restaurant. Construction is currently underway at the site.





Map Number	Project	Description and Status
4	Heritage Elementary School	Heritage School is now open as a STEAM (Science, Technology, Engineering, Arts, Math) Elementary School.
5	Veterans Sports Park	The Veterans Sports Park is a plan for a 31.5-acre park which will serve the recreational needs of the surrounding community. It will offer a wide variety of facilities including lighted soccer fields, ballfields, tennis courts, basketball courts, sand volleyball courts, and pickelball courts. A children's play environment, splash pad, and picnic areas are also proposed, as well as a Veterans Memorial Plaza. Grading work is complete at the site, and bids have been collected for Phase II of the project (which includes construction of the ball fields and equipment). Construction of the park has commenced, and it is estimated that construction of the park will be complete during early 2020.
ю	OC Social Services	The Tustin Family Campus for Abused and Neglected Children involves a multi- treatment campus which includes residential buildings and stand-alone homes, and a campus service center with a total capacity to serve 90 beds for abused and neglected children and their parents as well as emancipated youth. This project is complete.
4	Future City of Tustin Facility	The City of Tustin acquired this property through a recent land exchange with the South Orange County Community College District. The future use of this building is yet to be determined.
Ω	Orange County Rescue Mission	The Village of Hope facility is a 387-bed transitional home for the homeless which is operated by the Orange County Rescue Mission. This project is complete.
9	ATEP Campus	Construction is now complete for the first ATEP building which now houses career technical programs for Irvine Valley College.
2	Orange County Animal Care Facility	This new facility, which is replacing the former facility in Orange, is now open as of March 25, 2018.
ω	Rancho Santiago College District Sheriff's Training Facility	This Sheriff's Training Facility/Academy is now complete.

5	(Formerly Cornerstone 1)	This development proposal includes a variety of uses such as: creative office uses; a food hall; and, conference center including a connection into Tustin Legacy Park. Construction of Flight is now underway, with an anticipated completion date during the first quarter of 2019.
96	Cornerstone 2	Phase two of the Cornerstone development will consist of a variety of uses including research and development, office, and specialized employment uses.
10	Columbus Square	1,075 residential units are now complete within this neighborhood.
1	Fire Station #37	Orange County Fire Authority Station #37 moved from its old location off of Red Hill Avenue to this new location at Edinger/Kensington Park Dr. The Fire Station is now open.
12	The Village at Tustin Legacy	Construction continues to progress on the medical office portion of this new center which includes 248,292 square feet of retail and medical uses. The Health South (acute care) facility will commence grading soon. Many of the retail businesses are now open within the shopping center.
13	Orange County Regional Park	The County of Orange has future plans for an 84.5-acre regional park to be located surrounding the North Hangar. A concept plan has been approved by the OC Board of Supervisors. Please visit ocparks.com for further details on this proposed project.
14	Legacy Magnet School	The Tustin Unified School District (TUSD) is currently working on the design of a new magnet school called Legacy Academy, which will be a TIDE school focusing on Technology, Innovation, Design, and Entrepreneurship. A groundbreaking for the site was held on March 13, 2019, and construction of the new school is anticipated to be complete in 2020.
15	Mixed-Use Urban Village (Neighborhood D Community Core)	A mixed-use urban village concept within the community core of Tustin Legacy is proposed. Next steps will include the preparation of a concept plan and business plan as the basis for development of the urban village.
16	Amalfi Apartments	The Irvine Company has constructed a new apartment community consisting of 533 units adjacent to The District at Tustin Legacy.

	)	provide a range of housing types including senior housing, detached and attached single-family, multifamily, affordable housing, and mixed-use commercial

18	Jamboree Housing	Preliminary plans have been submitted by Jamboree Housing to provide 114 affordable rental housing units within Tustin Legacy in the area between Anton Legacy Apartments and The District at Tustin Legacy. The submitted plans are currently under review by City Staff.
19	Greenwood in Tustin Legacy & Greenwood Park	A total of 375 detached homes have been built by CalAtlantic Homes. Construction of the homes is now complete.
20	Anton Legacy Apartments & Victory Park	St. Anton Partners has completed construction of their 225 unit affordable apartments, and Victory Park is now open.
21	The District at Tustin Legacy	This Class-A Retail Development project has been completed. The District at Tustin Legacy offers a variety of retail services, restaurants, and entertainment venues.
22	Tustin Field I	376 residential units are now complete.
23	Tustin Field II	189 residential units are now complete.
24	Columbus Grove	465 residential units are now complete.
25	Tustin Legacy Linear Park	The City of Tustin is proposing to construct and maintain a 26-acre park and stormwater detention basin. Construction of Phase I of the park (detention basin) is complete, with Phase II of the park (landscaping through Armstrong Avenue, parking lot, restroom facilities) is anticipated to commence along with completion of the Flight project.
26	Army Reserve Relocation	The U.S. Army has relocated from their current Army Reserve Center located on Barranca Parkway adjacent to The District shopping center, to a new location at the north east corner of Red Hill Avenue and Warner Avenue.

#### 2019 Bill Package

#### SB 184 -- The Judicial Fairness Act of 2019

This bill to reform the Judicial Retirement System II would let judges leave the bench earlier, with the requirement that they defer their pension until their eligible date and, in many cases, take a proportional reduction based on fewer years of service credit.

#### SB 241 -- Local Government Contracts

SB 241 gives local governments and Joint Power Authority (JPA) member agencies greater input in bargained contracts before they go into effect.

#### SB 319 -- The High-Speed Road

SB 319 requires the Department of Transportation to create two additional lanes on Interstate 5 and State Route 99 north and southbound with unrestricted speed limits.

#### SB 359 -- Elections Code Spot Bill

SB 359 is a spot bill within the California Elections Code 9238. This legislation is acting as placeholder language for future use.

#### SB 408 - Willful Defiance Intent Bill

SB 408 contains intent language that would appropriate resources for educators when a pupil disrupts school activities or otherwise willfully defies the authority of school personnel engaged in the performance of their duties. This legislation is acting as a placeholder for future use.

#### SB 435 -- Reducing Burdensome Costs in Family Law Proceedings

SB 435 vests family law courts with the discretion to allow the admission of case-specific hearsay evidence in expert witness testimony on custody and financial issues.

#### SB 447 -- Public Parks Intent Bill

SB 447 is a bill declaring it is the intent of the Legislature to enact legislation to ensure the public has adequate park space.

#### SB 473 -- Voluntary Contribution Fund Intent Bill

SB 473 is a bill declaring it is the intent of the Legislature to reform the personal income tax voluntary contribution funds.

#### SB 496 -- Protections Against Financial Abuse of Elder and Dependent Adults

SB 496, known as Protections Against Financial Abuse of Elder and Dependent Adults, gives financial industry participants and state regulators new tools to help detect and prevent the financial abuse of vulnerable adults.

#### SB 511 -- DMV Voter Registration Transparency and Training

SB 511 would establish a committee to facilitate the sharing of information regarding the implementation of the Motor Voter program. The bill would also establish voter registration training for the Department of Motor Vehicles (DMV) employees.

#### SB 535 -- Counting Greenhouse Gas Emissions from Fires in Scoping Plan

Senate 535 would require that the Air Resources Board include greenhouse gas (GHG) emissions from fires, natural and human caused, in future iterations of the Assembly Bill 32 Scoping Plan.

#### SB 584 -- Wildfire Mitigation through Undergrounding of Power Lines

SB 584 would expedite opportunities for local jurisdictions located in Tier 3 fire-threat areas to underground current overhead electrical infrastructure for wildfire mitigation. The bill will also establish a Wildfire Mitigation Oversight Board to develop and implement policies that reduce the looming threat of more wildfires.

#### SB 598 -- The Open Financial Statements Act

SB 598 modernizes California's municipal finance reporting practices by replacing portable document format (PDF) audited financial statements with filings in inline eXtensible Business Reporting Language (iXBRL). It also establishes iXBRL audited financial statements as the only filings required from state and local agencies. To facilitate the migration to iXBRL, this bill establishes a multi-stakeholder process to oversee the development of an XBRL taxonomy suitable for public agency financial filings, and commission an open source software tool to enable agencies to create reports using iXBRL. Lastly, this bill requires the State Controller to post all public agency audit reports on their website.

#### SB 640 -- Mental Health Services: Gravely Disabled

would clarify the definition of 'gravely disabled' to focus on an individual's capacity to make informed decisions about his or her personal wellbeing.

#### SB 654 -- Governance and Finance Spot Bill

SB 654 is a spot bill within the California Government Code Section 56001. This legislation is acting as placeholder language for future use.

#### SB 689 -- Local Control of Needle Exchange Programs

SB 689 will amend the California Health and Safety Code Section 121349 to allow local governments a greater say in the location of clean needle and syringe exchange programs. Specifically, this bill restricts the California Department of Public Health (CDPH) from authorizing or re-authorizing needle and syringe exchange programs unless a city or county has approved the request.

#### SB 718 -- Housing Spot Bill

SB 718 is a spot bill within the California Government Code Section 65582. This legislation is acting as placeholder language for future use.

#### SB 754 -- Common Interest Developments Spot Bill

SB 754 is a spot bill within the California Civil Code Section 4230. This legislation is acting as placeholder language for future use.

#### SB 769 -- Public Employment & Retirement Spot Bill

SB 769 contains spot bill language in Government Code Section 20280 relating to public employees' retirement.

# Governmental Organization

Tuesday, March 12

**SB 21 (Dodd)**--Reduces the minimum amount of beer that must be produced on the premises of a brewpubrestaurant from 200-barrels per year to 100-barrels per year in order to qualify for a Type-75 brewpub-restaurant license.

SB 46 (Jackson)--Expands upon legislation enacted last year that authorized local governments to contract with public utilities to access the contact information of resident accountholders for the sole purpose of creating public emergency warning systems to include the University of California, California State University, and Community Colleges.

**SB 53 (Wilk)**--Amends the Bagley-Keene Open Meeting Act to specify that standing committees of state bodies must observe the open meeting requirements regardless of the number of members of the committee.

**SB 58 (Wiener)**--Requires the Department of Alcoholic Beverage Control to conduct a pilot project that, upon application by a qualified city, pursuant to a myriad of specified conditions, restrictions, and fees, extends of hours for bars (on-sale general licensees) to remain open and serving alcoholic beverages from 2:00 a.m. to 4:00 a.m..

# Human Services

Monday, March 11 **SB 173 (Dodd)**--Requires, for purposes of establishing a student's CalFresh eligibility, the state Department of Social Services to create a standardized form to be used by community colleges and universities to verify the workstudy eligibility of students who are approved and anticipate participating in state or federal workstudy.

**SB 234 (Skinner)**--Requires a city or county to treat a large family daycare home, which may provide care to up to 14 children, as a residential use of property for purposes of all local ordinances.

# Natural Resources & Water

Tuesday, March 12

**SB 8 (Glazer)**--Bans all smoking, including e-cigarettes and marijuana, on "state coastal beaches" and "state park units" and would require the California Department of Parks and Recreation to create signs and post them at entrances or strategic locations throughout state beaches and parks providing notice of the smoking prohibition.

**SB 62 (Dodd)--**Permanently extends legal protections for the "accidental take" of endangered species during routine agricultural activities. Requires reporting of the accidental take within 10 days.

SB 204 (Dodd) -- Requires the joint powers authority established to design and construct the California Waterfix (Delta tunnels) to provide the legislature, at least 60 days prior to entering into any contract for design or construction of Waterfix, information regarding the proposed contract to the Joint Legislative Budget Committee (JLBC) and the relevant policy and fiscal committees. Provides that if the JLBC or relevant policy and fiscal committees hold a hearing to review the contract, the joint powers authority shall not approve the contract for 90 days after the first hearing of the Legislature. Places similar requirements on DWR for the negotiation of any potential amendments of any long-term water supply contract.
